Currently, California/Kern County do not require social distancing or vaccine mandates for small events, therefore we will not be enforcing such restrictions. However, we do encourage attendees to take precautions including frequent hand sanitizing and wiping down of items, if applicable, between shoppers. When in doubt, wear a mask. If you begin to experience any COVID-19 related symptoms within 72 hours of the event we kindly ask that you not participate. This is for the health and safety of yourself, and our community.

Vendors are to donate a raffle item, valued at \$25 or more, for use by the Junior League of Bakersfield.
